Rules & Regulations:

1. Eligibility Criteria:

- o The nominee must be a woman actively involved in the Econo Lodge brand, either as a hotelier, operator, manager, or in a leadership role at a franchisee property.
- o The nominee must have a minimum of 5 years of experience in the hospitality industry.
- o The nominee must be in good standing within the Econo Lodge brand and ELFA.

2. Nomination Process:

- o Nominations can be submitted by peers, board members, ELFA members, or franchisees.
- o Self-nominations are also allowed, provided supporting documentation is submitted.

3. Judging Criteria:

- o **Operational Excellence:** How the nominee has demonstrated leadership and contributed to the operational success of their property (financial growth, guest satisfaction, etc.).
- **Leadership:** The nominee's role in mentoring or advancing women within the hospitality industry.
- o **Innovation:** Contributions to the advancement of the Econo Lodge brand, including any innovative practices.
- Community Impact: Engagement in community work, advocacy for franchisees, or involvement in ELFA activities.
- o **Dedication:** Overall dedication to the Econo Lodge brand and the broader hospitality industry.

4. Selection Process:

- A selection committee composed of ELFA board members, past award winners, and industry leaders will evaluate the nominations.
- The committee will review all submitted materials and may request additional information if needed.

5. Nomination Deadline:

- o Nominations must be submitted by February 15 of each year. Late submissions will not be accepted.

6. Award Presentation:

- The award will be presented annually at the ELFA Roundtable session during the Choice Hotels convention.
- The recipient will be recognized through a formal ceremony, with an official plaque and a profile feature in the ELFA magazine and a \$500 check.

7. Confidentiality:

 All nominations and supporting materials will be kept confidential and reviewed only by the selection committee.

8. Ineligibility:

- o Members of the selection committee are not eligible to be nominated.
- o Any nominee found to be in breach of Econo Lodge or ELFA policies will be disqualified.
